PRESIDENT'S MESSAGE

Progress and Challenge! The nineties have begun well for the Q.C.U.A. but these next few years provide great challenges for cricket generally and for our Association in particular. These are the themes of this year's message.

The Q.C.U.A. has continued from strength to stength over the twelve months just past. To the players, the most significant aspect of this progress would be the increased number of active Some years ago the Association took a stand with regard to the appointment of umpires, maintaining that umpires would only be appointed in pairs whenever possible. For a number of seasons, the players have had to take a greater part in our side of the game on a rotational basis in the lower grades. The season 1990/91 followed the trend of recent years and it is now possible that in seasons to come we will fill all matches with umpires in pairs. The past decision has been vindicated, but thanks must to to a number of people for the improvement. The Q.C.A. has done much over recent seasons, assisting with advertising and last season, the Q.C.C. and Brett Henschell assisted greatly in this regard. Within the Association, effort by Allocation, Coaching and Observer panels has been significant while the work of our first Recruitment Officer, Col Bertwistle, has been most important. Thanks to all who have helped in this progress. The challenge remains to maintain and increase membership.

The Executive Committee has worked well this year. To Nelma Grout as Secretary, to Merv Musch as the trusted keeper of the books, to Mike Ralston as Minute Secretary and to Paul Polkinghorne who took over as delegate to the Grade Committee, a special word of thanks for jobs well done. The Executive has had a number of problems to solve over the year and these have generally been approached with wisdom and in a professional and caring manner. Thanks to all those members of Executive who supported the Committee and me so well.

The Q.C.U.A. has covered its responsibilities across the State very well in recent seasons. In this coming seeason there will be fresh ideas afoot as to how these responsibilities may be met for the future. It will be important for the Association to approach this issue with an open mind, to look at what will be best for umpiring in Queensland and ultimately for the development of cricket in this State. It may be that the present system is the best possible but certainly we must look at potential improvements. The progress of the recent past must not blind us to the challenges of the future.

In recent years, the level of co-operation with the Q.C.A. and the interest they have shown in our Association has been of the highest order. President, Tom Veivers, Chairman Alan Pettigrew, the various committee and permanent staff have all been of great assistance. The Q.C.U.A. would not be as healthy as it is today but for the interest of these people. Our sharing in the sponsorship from major sponsor, Powers, has provided a financial stability our founders would have envied. Q.C.A. support in the establishment of the Peter Burge Medal has been greatly appreciated by the Q.C.U.A.

as was the support of the Sunday Mail and Parkroyal Dockside. This progressive step in Brisbane club cricket would not have been possible without the fine work of Alan Pettigrew, Barry Richards and Ian Sturgess of the Q.C.A. and of Gerry Duggan and Gary Smart of Parkroyal Dockside and the Sunday Mail respectively. Thanks to all who assisted and congratulations to the joint inaugural winners, Bob McGhee and Andrew Hammelmann.

In closing, congratulations must go to Colin Timmins for his efforts at the top levels of cricket, to Col Bertwistle for his winning the Bob Spence Medal for 1990/91 and to John Rowe who handled his responsibilities looking after the social side of things in a competent and relaxed manner. It was a good season overall, one of progress - the challenge to make next season and the future as good or better awaits us.

PETER BURGE MEDAL

1990/91 was the inaugural year of the Peter Burge Medal for the Club Cricketer of the Year. For sometime, the Q.C.U.A. has felt that there should be more recognition for club performances. Our proposal for a Club Cricketer of the Year Award was presented to the Q.C.A. and accepted.

It was decided that the medal be named after a "homegrown" living Queensland cricket player and who more appropriate than Peter Burge. Peter who is generally regarded as the best batsman produced in Queensland, played with Easts from 1941 until 1969 and hit 3879 First Grade runs. In a 233 match First Class career, he amassed 14640 runs at an aveage of 47.53. He played 42 Tests and 83 Sheffield Shield matches. He captained his State 29 times and was a State Selector for 10 years. Peter was made a Life Member of the Q.C.A. in 1989.

The winner of the award was determined by the votes allocated by Q.C.U.A. umpires in First Grade who each day cast up to 20 points per game per day with 10 of those points being allocated to the outstanding performer of the day in each game and up to 10 points being split among a maximum of three players.

The Umpires' Association designed and had made the medal and the perpetual trophy. The Sunday Mail publicised the award by regular reports on the progress of points and the outstanding players in each game. Dockside Parkroyal provided the excellent venue for the presentation of the medal.

At a cocktail party at Dockside Parkroyal, the five finalists - Peter Cantrell, Andrew Hammelmann, Ken Healy, Bob McGhee and Scott Muller were called up on stage prior to Peter Burge presenting the medals to joint winners - Andrew Hammelmann (Souths) and Bob McGhee (Toombul) who tied on 54 points. Andrew took 44 wickets up to Round 12 with an average of 18. This was the leading Q.C.A. bowling average while Bob McGhee was the leading First Grade wicket-taker with 47 wickets at an average of 22.

The Q.C.U.A. wishes to thank the Sunday Mail and Dockside Parkroyal for sponsoring the award and the Q.C.A. for their enthusiastic support and assistance.

EXECUTIVE COMMITTEE

The Executive Committee met on ll occasions during the year under review. At the Annual General Meeting, Messrs. Taylor and Parker and Miss Anderson did not seek re-election. In the vacancies created, Mr. Neville Scholes was elected to Vice-President and Messrs. Paulsen and Durston were elected to the Committee.

The 1990/91 season was another very rewarding one for the Association with the culmination of a number of projects from previous seasons as well as several new developments. During the year, the main items of business were:

- * Retirement Fund: The Q.C.A. has approved an Umpires' Retirement Fund but have made some amendments to the original proposal. The Q.C.A. shall finance this fund and be responsible for maintaining accurate records of the number of matches umpired and the level of match credits for each umpire. We are confident that an Umpires' Retirement Fund will encourage members to remain active umpires longer.
- * Umpire Recruitment: This concept was introduced in the off season of 1990 and has proved to be a very successful initiative of Col Bertwistle and the Association. The details of this concept are outlined in the relevant Report. Thanks are extended to Col for accepting the position of Recruitment and Development Officer and for doing an excellent job. In preparation for the 1991/92 season, advertisements have appeared in newspapers and a New Members' Night was held in early July with 10 prospective umpires attending. Very enncouraging for the forthcoming season.
- * Sponsorship: The 1990/91 season saw Power Brewing become the major sponsor of Queensland cricket. Through the efforts of Mr. Alan Pettigrew and the Q.C.A., the Q.C.U.A. received \$6,000.00 in sponsorship from Power Brewing for which we are very grateful. Umpires wore the Powers logo on their shirts while officiating.

The Q.C.U.A. also received samples of Sundown sunscreen from Johnson & Johnson for members to use while umpiring.

* Peter Burge Medal: March, 1991 saw the inaugural presentation of the Peter Burge medal to the Club Cricketer of the Year after two years in the making. Details of the medal and its presentation appear elsewhere in this Report. The Q.C.U.A. is indebted to the Q.C.A. for allowing us to make this award and for assisting us in its planning and presentation.

Thanks are extended to Paul Polkinghorne for designing the medal and the perpetual trophy.

* Umpires' Badges: It has been the belief of our Association and umpires throughout Queensland, that all umpires should wear a badge indicating that they are part of the Q.C.U.A. After discussions at the 1990 Country Seminar, it was decided that a cloth badge identical to our's in colour and design be made. Around the top were the letters Q.C.U.A. and on the bottom was the name of the town or Association. This badge replaces the Country Cricket Association badge previously worn.

The Executive also had made new badges for our own members as our stock was greatly depleted and did not display our present name. Unfortunately these badges were not to the exact design or quality we expected so a new set is being made in preparation for the 1991/92 season. The Q.C.A. has continued to supply our badges.

* Association ties: December, 1990, finally saw the arrival of 200 Association ties in the colours maroon, navy and grey.

For a couple of years the Association had been dealing with Rembrandt Ties in South Australia but having become dissatisfied with Rembrandt's design and craftsmanship the Executive decided to commission A. Royale in Brisbane to produce the ties. The Association was required to pay Rembandt Ties for the work done to date. Thanks must be extended to Paul Polkinghorne for his work in designing our tie.

- * Captains' Report on Umpires: For the second successive year this report was revised with the view to making it easy for the Captains to complete and still contain relevant information on an umpire's performance. In addition to completing the report after each day's play and showing it to the umpires for their signature, Captains were asked to give an overall rating for each umpire for the purposes of the Bob Spence Medal.
- * Constitution change: At an Extraordinary General Meeting in December, 1990, the Constitution was amended with regard to the number on the Board of Examination and Coaching. The number of members to be elected to the Board for the forthcoming season shall be determined by the members at the July General Meeting each year.
- * Association Banner: A banner was made so that it could be displayed at functions and was done so at the Peter Burge Medal Presentation and our End of Season Dinner.
- * Meetings with Q.C.A. officials: The Executive Committee was very happy to welcome Mr. Alan Pettigrew to our September and May meetings and Mr. Barry Richards to our May meeting. The Q.C.U.A. enjoys an excellent relationship with the Q.C.A. and we are very appreciative of their assistance and support.

At the May meeting the Q.C.A. agreed to pay for the advertisements to recruit umpires, to assist in subsidising our seminars, that our sponsorship from Power Brewing would continue and that the Peter Burge Medal would remain a part of the First Grade scene.

Your Executive is hopeful that prior to the 1991/92 season commencing there will be a meeting to deal with the entire system of reporting players, player behaviour etc.

- * Umpires' Advisors' meeting: Mr. Mel Johnson attended a meeting in Adelaide in May. Mr. Johnson felt the meeting was beneficial and many topics of concern to all Umpires' Associations were discussed such as:
- recruitment, training, retention of umpires.
- allocation of umpires.
- Captains' report on umpires.
- Fitness of umpires especially First Class.
- neutral umpires.
- umpires' entrance exams.

Mr. Johnson was asked to produce a handbook for all umpires. Hopefully this will be printed for the forthcoming season.

As this report indicates, the Executive Committee has had a very busy but fulfilling year and we look forward to the 1991/92 season.

LIFE MEMBER - 1990

On the 1st August, 1990, at the Annual General Meeting, Mr. Jim Taylor was awarded Life Membership.

Jim Taylor joined the Association in 1976/77 and was an active member until the end of the 1989/90 season. Jim umpired at First Class level, was a holder of the First Grade Badge and the 100 Game Badge.

Jim was a very committed member of the Association on and off the field. Throughout his 14 years of umpiring, he was available for nearly every Saturday and Sunday especially for Under 19 games in which he had a special interest. Off the field, Jim was a member of the Board of Examination and Coaching for many years, always prepared to give seminars and he also served on our Executive Committee. He was responsible for encouraging many young men to join our umpiring ranks by conducting umpiring seminars at schools.

Jim's involvement in cricket is not limited to umpiring. For over 20 years, Jim has been heavily involved in Queensland Youth Cricket, organising carnivals, coaching and managing youth teams, serving on the B.Y.C.A. and the Q.Y.C.C. and being the Queensland Delegate to the A.Y.C.C..

Because of health and family matters, Jim no longer officiates and now holds the position of coach of Valleys Cricket Club.

The Queensland Cricket Umpires' Association thanks Jim Taylor for his involvement and promotion of our Association over many years and congratulates him on an honour well deserved.

THE BOB SPENCE MEDAL

RECRUITMENT AND DEVELOPMENT OFFICER'S REPORT

This concept was introduced in the knowledge that for some years our membership was static therefore not only should our attention be directed towards recruitment, but it was becoming increasingly evident that preparation and ongoing development was necessary to maintain continuity.

New members were invited to attend an "introductory night" on the 4th July, 1990 to meet our President and his Executive and during the evening, the structure of the Association was outlined incorporating the basic functions of related committees.

Monthly seminars were conducted prior to General Meetings and were regularly attended by First Class umpires who offered advice and guidance.

Practical problems encountered during the season were widely discussed as were the general laws of cricket.

Our thanks to the Q.C.A. and also to Brett Henschell for their support in advertising and media coverage.

In summary the year was gratifying with membership increasing 13% to 70.

My personal appreciation to the members who joined us during 1990/91 for their enthusiastic contribution to the new concept which has ensured our ultimate goal of providing umpires for all grades is achievable in the short term.

BOARD OF EXAMINATION AND COACHING

The role of the Examination and Coaching Board has broadened considerably over the past few years. Besides being one of the main fundraisers for the Association it also has to attend to its own members, members of other Associations listed later, and to affiliated (Country) Associations. Maybe it is time to have either an extended Board or have two separate Boards - one for our own needs and one for affiliated bodies.

Maryborough again hosted the Q.C.U.A. seminar for umpires throughout Queensland. A total of 68 umpires (excluding our own Association) attended and represented 18 different Associations. This seminar has been one of the most vital things to happen in umpiring in the last two decades and the support and enthusiasm of the Country Associations is proof of this.

The Board conducted seminars (sometimes of 2 or 3 nights duration) for Sunshine Coast, Brisbane North Star Juniors, Ipswich and West Moreton Church Union, Queensland Womens' Cricket, Queensland Churches Cricket, Queensland Second Division, Anglican Church Grammar School and Brisbane Girls' Grammar School.

The Board also marked examination papers from 17 Associations including Mt. Isa, Chinchilla, Cairns, Townsville and Ayr.

The inaugural live-in seminar held at Alexandra Heads Hotel/Motel proved very successful with very good support from our members. These seminars can only be beneficial even if, the one and only plus out of them, is that you get to know your colleagues better.

Coaching sessions were held at each General Meeting with the refresher exam being held in November. The support of the members in assisting the Panel at the seminars and the coaching sessions held at meetings was gratefully accepted.

The Recruitment and Development Officers' work in conjunction with the Board has proved to be a great initiative. The guidance and coaching to our new members can be best gauged by the impressive performances of all our new members during the past season.

Good luck and good umpiring during the 1991/92 season.

ALLOCATION PANEL

The past season's allocation of umpires was no easier than previous seasons but happily the difficulty arose through two very welcome signs. One was the increased number of umpires and the second was the quality of the "new" umpires.

The Allocation Panel of Mel Johnson, Nelma Grout, Merv Musch and Col Bertwistle meet fortnightly from 5.00p.m. - 8.00p.m. (minimum). I say this to give members an insight into the time taken to allocate. It is not a haphazard affair and I refer you to last year's Annual Report for the criteria under which we work. I can also assure you that the Q.C.U.A. is the envy of other States because we allocate "our own". This was borne out by Advisors from each State at a recent A.C.B. Conference.

The inherent danger of our system as against other States (Assistant Secretary of Associations; 3 or 4 members of Grade Clubs allocate) is that it will self destruct. Before you query your allocation next time - ask yourself this question - "Would I query the Assistant Secretary of the Q.C.A.? Just because the Allocation Panel is readily accessible does not give you the right to query your allocation.

This year 58 members were available for appointment during the season which is an increase of 8 on the previous season. The number of umpires who officiated in each Round were: Round 1 - 45, Round 2 - 42, Round 3 - 48, Round 4 - 45, Round 5 - 48, Round 6 - 50, Round 7 - 47, Round 8 - 48, Round 9 - 52, Round 10 - 50, Round 11 - 51, Round 12 - 49.

The average number of umpires who officiated per Round was 48 as compared to 41 the previous season. We are slowly approaching our goal of 60 on the field.

OBSERVERS' REPORT

The past season saw the Q.C.U.A. take advantage of the Q.C.A.'s generous offer of an extra observer and we welcomed Peter Enright and Ray Green to the ranks. With three observers a greater coverage was attained and most members received three written observer's reports.

The observer's role is simple. He is there to help all umpires improve their technique and pass on tips or comments from players, officials and scorers so as each individual umpire can make a self-assessment or adjustment. The observer is also available to render advice if you find yourself in a sticky situation "over the state of the pitch, behaviour of players, legitimacy of a bowler's action or any one of those 101 little problems that occur.

All three of us try to write as positive a report as we can to build your confidence and your umpiring ability. This should be taken for the grade you are in and not as a recommendation for higher grades.

Observers are available for discussion of your report before and after the meetings and we would welcome your thoughts.

BRISBANE GRADE COMMITTEE

The end of the 1990/91 cricket season will see the completion of the second year that the Queensland Cricket Umpires' Association has had representation on the Brisbane District Grade Committee. The Grade Committee met on the last Tuesday of every month to discuss the general conduct and give rulings on matters associated with the control of Grade matches. The Associations' concerns and comments were raised by Paul Polkinghorne who attended all meetings except for one.

Matters discussed at the Grade Committeee meetings and of interest to umpires were as follows:

- With the Q.C.A. apprroval the Grade Committee increased an umpires' allowance to \$40.00 a day with a partner, \$50.00 a day without a partner and \$45.00 for Sunday games.
- The entry of the Gold Coast into the District Competition and the Country Centres into the Gabba Sporting Products One Day Competition resulted in a large number of members being allocated to matches throughout South East Queensland.
- The introduction of extended playing time in First and Second Grade for time lost created some concern in relation to the time for the tea interval and the drinks break in the last session. It appears this matter will be resolved as we recommended for the 1991/92 season.
- The handing down of a competition points penalty on a district club for poor wicket preparation revived the concern of some members. The Association resolved to continue its stance to not participate in any wicket reporting as it would be beyond the expertise of most of the members.
- It was decided to review the minimum number of overs for lower grades at a time when the Umpires' Association will be in a position to allocate umpires to all games.
- The Q.C.A. and Grade Committee are investigating the possible introduction of an Under 16 competition to be conducted on Sundays in conjunction with Under 19 matches with shorter playing hours.
- The parameters of the whole judiciary system associated with the reporting of players is still under consideration. It is anticipated recommendations will be tabled during the new season.

The Umpires' Association has welcomed the opportunity to participate in the running of Q.C.A. Grade cricket and our input has been well received. We look forward to continuing our involvement on this Committee.

QUEENSLAND CRICKET ASSOCIATION

The Annual General Meeting of the Q.C.A. Ltd. was held on Tuesday, the 14th August, 1990. Mr. Tom Veivers was re-elected as President, while Mr. Alan Pettigrew retained the positions of Q.C.A. Chairman and A.C.B. Delegate and Dr. Cam Battersby was re-elected as an A.C.B. Delegate. Mr. Max Walters did not seek re-election as Treasurer and the position was filled by Mr. Brian Sully. Messrs. Anstey, Burge, Holland, La Frantz, MacLean and Mullins were elected as Vice-Presidents of the Association.

Messrs. Allan, Gaskell, Rice, Trimble and Walters were duly elected as the State Selectors for 1990/91.

Mr. Wep Harris was made a Life Member of the Q.C.A. at the Annual General Meeting.

1990/91 has been a year of many changes for the Q.C.A. Prior to the season commencing Trevor Hohns was appointed Captain of the Queensland team and Jeff Thomson as Coach. Due to the resignation of Richie Robinson, Toot Byron became the State Director of Coaching. At the conclusion of the season, Mr. Grantley Evans retired as Administration Manager and was replaced by Mr. Graham Dixon, a long serving official and player of Sandgate/Redcliffe District Cricket Club.

Carphone did not continue their sponsorship of Queensland cricket and the Q.C.A. was very pleased to welcome Power Brewing as the chief sponsor of Queensland cricket for three years.

The main item of business for the Q.C.A. during 1990/91 has been the restructuring of the Q.C.A. At an Extraordinary General Meeting of the Q.C.A. held on the 4th June, the proposed amendments to the Memorandum and Articles of the Association were approved. At the next Annual General Meeting a Board of Directors of 10 will be elected. This Board will consist of Chairman of the Q.C.A., one delegate to the A.C.B., Tresurer, Chief Executive Officer and five Board members, including one representative of the Q.C.C.A. The President will be an ex-officio and non-voting member of the Board.

During 1990/91, the Q.C.A. paid for any advertising required to recruit umpires, paid for our new badges, subsidised our seminars with \$1,000.00 and issued a grant of \$1,000.00 to our Association. They also organised sponsorship of \$6,000.00 from Power Brewing and have agreed to fund our Umpires' Retirement Fund. This financial assistance is very much appreciated and sincere thanks are extended to the Q.C.A.

Throughout the season, members of our Association have been invited to attend the Launch of the Cricket Season, the Q.C.A. Trophy Night and the Sponsorship Dinner. At the Trophy Night, Mr. Col Bertwistle was presented with the Bob Spence Medal by Dr. Cam Battersby, A.C.B. Delegate.

The assistance and support accorded us by Messrs. Pettigrew, Battersby and Richards, the Executive Committee and the Q.C.A. staff is acknowledged with gratitude.
