FOOTAGE, IMAGES OR SOUND FROM THE LIVE STREAM MAY BE USED BY THE PREMIER CRICKET CLUB OR THE STATE AND TERRITORY ASSOCIATION, OR THEIR REPRESENTATIVES OR PARTNERS (INCLUDING INTERACT SPORT PTY LTD) FOR OTHER PURPOSES WHICH MAY INCLUDE:
