## PRESIDENT'S REPORT

Ladies & Gentlemen,

It is with mixed feelings that I write this report - a touch of regret that I did not achieve all the goals I set for the Association and a feeling of optimism with new thinking presiding over the Association.

The biggest disappointment was the failure to gain any support for the video made on umpiring. The video may not have fulfilled all requirements of the governing cricket bodies but it was the only attempt to improve Australian umpiring standards in the past decade at least. If umpiring is to improve, somebody, somewhere, has to take positive steps as, indeed, steps were taken to improve players' ability.

The past season has seen two major innovations - the re-structuring of the Queensland Cricket Umpires Association and the inaugural presentation of the Bob Spence Medal.

The Q.C.U.A. was re-structured after requests from Warehouse and 2nd Divisions to meet with your Executive. The aims of this Association are simple - to disseminate information regarding law changes and provide a forum for the interchange of umpiring ideas, techniques etc. With the latter point in mind I recommend to you the inaugural Q.C.U.A. meeting in Bundaberg 24th and 25th August, 1985.

The introduction of the Bob Spence Medal provided keen incentive for the members. Points were accumulated throughout the season for umpiring all rounds, Sunday games, attendance at meetings and seminars, taking refresher examinations and an average of the marks awarded by the captains. Our congratulations go to Merv Musch on being awarded the first Bob Spence Medal and congratulations also to the eight finalists who came from all grades of umpiring. This medal and perpetual trophy is well worth striving for. We thank Bob Spence for his continued support as patron of our Association.

We must all strive to improve our standards of umpiring. Regular half hour coaching is given at meetings by the Examination and Coaching panel. They also pass onto umpires helpful hints on how to overcome problems mentioned in the captains' report. However, all too frequently the umpires in need of help do not attend meetings. Very often a minor flaw in your technique can be rectified and make your umpiring more enjoyable by speaking to one of the Examination and Coaching panel.

Our Association enjoys a very harmonious relationship with the Q.C.A. Frequent meetings, both formal and informal have helped to iron out mutual problems. Perhaps the two major problems facing cricket in Brisbane are the unavailability of umpires and the behaviour of club players. Both of these areas should be given thought by both, our Association and the Q.C.A.

My sincere thanks go to the hard working Executive who willingly give their time and effort to sort out the problems that face our Association, the Social Committee who work so well for the benefit of us all, the Examination and Coaching Panel who have functioned very well in the advisory capacity and to Nelma, the Secretary, for her indefatigable work. Nelma goes about her work so efficiently that nobody will know just how much she means to this Association until she steps down from the Secretary's position.

I wish everybody success in his umpiring during the 1985/86 season and I hope my successor as President will enjoy the same support as I have had.

#### **LIFE MEMBER - 1984**

Now in his 71st year, Les has umpired continuously since 1973 and holds a First Grade Badge. Les and the Association are proud of the fact that he has only missed attending two meetings since he joined the Association. The Association appreciates his continuing involvement both in umpiring and as an administrator.

## EXECUTIVE REPORT

This year, new members to the Executive were John King and Col Timmins.

Executive Committee meetings were called on 10 occasions and attendances were as follows:-

This season saw a further change in the captains' reports with space being provided on reports so that captains can provide more details on umpires' performances. Also, as a result of discussions with the Q.C.A., an umpires' observer was introduced and his duties were to view umpires in the field and liaise with the Coaching and Allocation Committees. Mr. Bob Crouch was appointed as Umpires' observer but due to serious illness could not continue in the second half of the season and was replaced by Mr. Bob Young.

Members of the Executive met with the Grade Committee in April. Some of our suggestions which are awaiting confirmation of their implementation are: A completely new Captains' report which will have ratings of A, B, D, E rather than 1 - 10, an increase in our allowance which in future will be reviewed each year and the allocation of two umpires' observers, one for the north and south side.

Copies of the umpiring video were bought by the Q.C.A. and the majority of State Umpiring Associations. Although not many copies have been sold, our Executive has used it extensively in Training Nights. Members of the Executive showed the video and spoke about the laws of cricket at a number of district clubs at the commencement of the season, to the Women's Cricket Association and also to cricketers in Beaudesert. Everyone who has seen the umpiring video feels it is excellent for both players and umpires.

Unfortunately the Association has not been able to repay the loan which the Q.C.A. so generously gave us as quickly as we had hoped. The loan was to be repaid from the proceeds from a second art union but this did not eventuate. The Executive has written to the Australian Cricket Board asking them to apply to the Commonwealth Government for an allocation of money towards the video.

Our thanks go to the Q.C.A. and the office staff for their assistance and co-operation throughout the year.

First Grade Umpires, again awarded points for the Club Cricketer of the Year which is sponsored by Radio Station 4BC. This year's winner was John Hill of South Brisbane District Cricket Club. The Association is grateful to 4BC for its assistance on rain affected days by broadcasting matches which have been cancelled.



Regrettably for the Association, our President Mr. Mel Johnson will not be standing for any office in the forthcoming season. On behalf of the Executive and the members of the Association, I wish to thank him for his efforts and contributions during his three years as President and wish him every success for the future in umpiring and work.

### THE BOB SPENCE MEDAL

One of the main achievements of the Association this year was the introduction of The Bob Spence Medal which was named after our Patron and long serving Q.C.A. scorer and official, Bob Spence.

A subcommittee of Mel Johnson, Merv Musch and Col Timmins worked out how the points for the medal were to be allocated. The way the points were allotted, all umpires in the Association were eligible to win.

Thanks are extended to Athol Fulwood who was statistician for the award. The collation of these points took a great deal of time and effort and was greatly appreciated by the members.

At the Umpires' Dinner, the top eight contenders namely Col Bertwistle, Mick Harvey, Les Heath, John King, Steve Lanigan, Phil Latimer, Merv Musch and Neville Scholes were announced. This was followed by the Presentation of the medal to our first winner, Merv Musch. The Association congratulates Merv on winning the medal.

Merv Musch has been a member of our Association for ten years. He started umpiring lower grade matches and has been umpiring in First Grade for the past eight years and also holds a First Grade Badge. Merv has also been active in the Association's administration, having held positions as Vice President and Treasurer, as well as being a member of the Executive Committee, the Examination and Coaching Panel and the Social Committee.

## SOCIAL COMMITTEE

The Social Committee has been very busy throughout this season and I would like to thank the members of this Committee very much for all their efforts in organising the various functions and in fundraising. This committee has been very successful.

The Social Committee got the 1984/85 season off to a good start with a barbeque on the 19th August at Nelma's place. Forty people had an enjoyable lunch and afternoon with a profit of \$67.00 being realised.

As in previous years, the Committee organised a Christmas Party. This year, this function was held at the University Club on Friday, the 1st December, 1984. The 21 people who attended enjoyed a cold smorgasboard of meats, salads and sweets. The Committee was disappointed with the numbers and will be giving serious consideration to whether this function will continue. Members contributed various goodies towards a Christmas Hamper which was won by Mrs. Sherelle Musch. To the wives who assisted with the party, the Committee thanks you for your support.

The season concluded with the Umpires' Dinner Dance held at the Ridge All Suites Inn on Friday, the 12th April, 1985. The highlight of the evening was the inaugural presentation of the Bob Spence Medal by our Patron Mr. Bob Spence. This function was well attended by 66 people. It was very pleasing to have representatives from Valleys, Easts, Souths, Norths and University join us in our end of season festivities.

Thanks must be extended to University for providing us with an excellent venue for our Christmas function. We are very appreciative of your support.

Throughout the season raffles were run at our Monthly General Meetings and the Committee thanks those members who donated prizes and sold the raffle tickets.

At the conclusion of each General Meeting members were invited to stay for the Happy Hour. Thanks to Steve Lanigan and Merv Musch for acting as barmen during the Happy Hour.

One of the functions of the Social Committee is to raise funds throughout the season to subsidise the end of season dinner. Thanks to your support this year the Committee was able to subsidise the dinner and also pay for ten Bob Spence Medals.

## MEMBERSHIP

At the conclusion of the 1984/85 season, membership was seventy-seven, which includes our seven Life Members. Twenty-two new members joined the Association during the season which was an increase of two on the previous season.

Of our seventy-seven members, only fifty-six officiated in one or more games. Although our membership numbers remain the same, unfortunately the number of active umpires has decreased. Congratulations and thanks are extended to nine of our members who officiated in all Q.C.A fixture rounds. Twenty-four umpires officiated in the Gabba Sporting Products Competition and twenty umpires officiated in the U19 Competition.

Congratulations are extended to Col Timmins on being included on the International Panel and to Tony McQuillan who officiated in his first International match between Queensland and Sri Lanka. George Durston and Neville Scholes made their First Grade debuts and Neville also officiated in his first Q.C.A. Final.

Our members were asked to officiate at several games and carnivals throughout the season, including pre-season trial games, a six-a-side competition at Norths, the Australian Comworks carnival the Australian Primary Schools carnival, the final of the T.A.S. competition and games between Ampol & Castlemaine and Westpac and A.G.C.

Our Association also was able to assist the Queensland Womens' Cricket Association by officiating in their knock-out competition and their finals. Some of our members were fortunate enough to officiate in the Second Women's Test Match between Australia and England and also in two international matches between Queensland and England.

It is very pleasing this season to see a father and son both members of our Association. I am sure this is a first for the Association. Congratulations Rob and Clayton Lachmund.

Four more members, Nelma Grout, Merv Musch, Bill O'Neill & Bob Young made this season their tenth with the Association. There are now eleven members who have achieved at least 10 years active involvement with the Association. On behalf of the Association we congratulate these members and thank them for their contribution to date and look forward to their continued involvement with the Association.

### **BOARD OF EXAMINATION AND COACHING**

This year's Examination and Coaching Panel was a very active Committee and it has had a successful year.

They introduced group discussions and coaching sessions at each monthly meeting. These were very helpful to the members especially our newer ones. At the November General Meeting, members were given the opportunity to do a refresher examination which had been written by the three members of the Panel. At the December General Meeting, members formed groups and discussed various questions on the paper. The members found this very beneficial.

The only disappointment for the Panel was the seminar they organised for the 3rd September to which only seven people attended, six members plus a prospective umpire. Another pre-season seminar has been organised this year, and it is hoped more people will attend.

The Committee has not been idle during the off season and has written a new entrance examination.

### **UMPIRES ALLOCATION COMMITTEE**

For the second year, this Committee was appointed by the Executive of this Association and again consisted entirely of our members. Although this season, the number on the Committee was reduced to three.

As allocating umpires to games two rounds in advance did not prove successful last season, the Committee reverted to allocating umpires on a round by round basis. Again this season, there was the problem of umpires not returning their cards to the Q.C.A. office or notifying the Q.C.A. by the specified time of their availability. This makes the Allocation Panel's task even more difficult than it otherwise would be.

The Committee wishes to express their sincere thanks to Ian and Christine at the Q.C.A. for all their assistance throughout the season.

## QUEENSLAND CRICKET UMPIRES ASSOCIATION

The Queensland Cricket Umpires Association was formed on the 10th October, 1984. It consists of members from ten Associations from around South East Queensland. Hopefully next year, members from Umpiring Associations throughout the State will be able to join.

The object of the Association is to supply all Umpiring Associations with any changes to rules and to answer any questions on the rules of cricket.

The Q.C.U.A. has also set an examination paper of thirty-five questions which will be an entrance examination to all members and a card will be given to each member on passing the examination.

Unfortunately, N.S.W. has left the F.A.C.U. but hopefully they will reconsider.

There was no F.A.C.U. Conference this year but we hope to host the next conference in 1986.

### **UMPIRES RECRUITMENT COMMITTEE**

The Recruitment Committee of Vic Holland, Mel Johnson and Col Bertwistle held a meeting very early in the season.

A seminar was organised by this committee on September 8th for members of the junior division. Some of our senior umpires lectured at this seminar, to which 80 people attended. At the conclusion of the seminar, people had the opportunity to sit for an examination and if successfully passed, received a certificate.

The Queensland Cricket Association again granted a credit of \$500.00 for any expenses incurred for Recruitment Seminars.

### **QUEENSLAND CRICKETERS' CLUB**

We would like to express our sincere thanks to the management and staff of the Club for their assistance throughout the 1984/85 year. We are most appreciative of the Club's gesture in allowing the Executive Committee the use of the library for meetings.
