The main items of business handled by the Executive Committee are as follows:

Interstate Umpires' Seminar - With the financial assistance of Queensland Cricket, the Executive Committee supported the initiative of sending two members of our Board of Examination and Coaching to the South Australian Cricket Umpires' seminar. The two members found this very beneficial and we are planning to continue this venture.

ACB National Exam - Congratulations and thanks must be extended to our Board of Examination and Coaching who has been kept extremely busy throughout the season marking the very extensive ACB National Exam which has been completed by the majority of umpires throughout Queensland.

Squirt Bottles - For a couple of seasons, umpires have been becoming increasingly concerned about the hygiene of taking drinks on the field. It was felt that each umpire should have an individual squirt bottle. Thanks to Castlemaine Perkins, who provided us with eighty squirt bottles free, this significant improvement has been achieved.

Coca-Cola Matches - A maximum of fifty dollars was approved for accommodation expenses incurred by umpires who had to stay overnight when officiating in Coca-Cola matches in the country.

**Umpire Recruitment** - In line with continually improving our training for new umpires, the Executive Committee approved an additional \$1,000 if needed after a recommendation from our Recruitment and Development Officer.

Handbook Changes - Through our Grade Committee Representative the Executive Committee submitted a number of recommendations for changes to the QCA Handbook. Although the 1996/97 handbook is not yet printed, it appears that most of our recommendations have been implemented.

**Players' Injuries** - Due to the concern of a number of our members, we have initiated investigations through the ACB in relation to litigation matters. At the recent Director of Umpires' Meeting, considerable time was devoted to legal concerns of umpires.

**Incorporation** - The Executive has resolved to proceed to incorporate the Association.

Unfortunately, Ray is unable to continue as President. On behalf of the Executive Committee, I would like to thank him for his efforts throughout the year.

# **GRADE COMMITTEE REPORT**

The Grade Committee met on a number of occasions throughout the season and have recently completed its off-season meetings. In addition, numerous decisions of an urgent nature were made by telephone.

The Committee was chaired by Queensland Cricket Director, Damian Mullins, and consisted of four members from the twelve clubs and an Umpires' member. The Committee is chosen by the Queensland Cricket Board of Directors. Ian Sturgess of Queensland Cricket acted as Secretary and Administrator for the Committee. Prior to meetings of the Delegates Council, the Grade Committee met with representatives of all clubs, to inform and gauge opinion.

The nitty-gritty of the season revolved around applications from clubs on issues relating to the regulations. A survey of players and umpires was conducted indicating overall satisfaction with the manner in which Grade Cricket has been organised, but making a few suggestions for minor improvements.

In the winter the Committee has met very regularly and a number of alterations to the clarifications of the regulations have been agreed to for the forthcoming season. Umpires will need to read their handbooks closely for these changes which, generally, are to their advantage. A major simplification is that all one-day games will now be played under full one-day conditions.

It was very clear in meetings that the problems and difficulties of umpiring are understood by members of the Committee, and that the efforts and good work of umpires is greatly appreciated. It has been a privilege to have served as the umpires' member of the Grade Committee for the 1995/96 season.

#### INDEPENDENT AUDIT REPORT

To: The Members of the Queensland Cricket Umpires' Association

# Scope

We have audited the attached special purpose financial report comprising the Income and Expenditure Statement and the Balance Sheet for the year ended 30 April 1996. The Association's Executive Committee is responsible for the preparation and presentation of the financial report and the information contained therein, and have determined that the accounting policies used are consistent with the financial reporting requirements of the Association's constitution and are appropriate to meet the needs of the members. We have conducted an independent audit of the financial report in order to express an opinion to the members of the Queensland Cricket Umpires' Association on its preparation and presentation. No opinion is expressed as to whether the accounting policies used are appropriate to the needs of the members.

The financial report has been prepared for distribution to members for the purpose of fulfilling the Executive Committee's financial reporting requirements under the Association's constitution. We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

Our audit has been conducted in accordance with Australian Auditing Standards. Our procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial report. These procedures have been undertaken to form an opinion as to whether, in all material respects, the financial report is presented fairly in accordance with the accounting policies described in Note 1 to the financial statements. (These policies do not require the application of all Statements of Accounting Concepts and Accounting Standards).

The audit opinion expressed in this report has been formed on the above basis.

# Qualification

As is common for organisations of this type, it is not practicable for the Association to maintain an effective system of internal control over donations, subscriptions and other fund raising activities until their initial entry into the accounting records. Accordingly our audit in relation to fund raising was limited to amounts recorded.

## **Qualified** audit opinion

# QUEENSLAND CRICKET UMPIRES' ASSOCIATION NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 1996

# **Note 1: Accounting Policies:**

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Queensland Cricket Umpires' Association's constitution to prepare accounts. The Executive Committee has determined that the Association is not a reporting entity as defined in Statement of Accounting Concept 1 "Definition of Reporting Entity". Accordingly there is no requirement to apply accounting standards in the preparation and presentation of the report.

Consistent with prior years the Executive Committee has used the cash basis of accounting with additional recognition for the depreciation of the Association's fixed assets. The cash basis of accounting means that income is recognized when cash is actually received, not when it is due to be received, and expenses are recognized when the payments are made rather than when a liability exists.

Consistent with prior years the value of inventory on hand has been determined on the basis of normal sale price.

# GRADE ALLOCATION PANEL REPORT

With the expanding Grade competition, more umpires were required each round. It is pleasing that, with a couple of exceptions, we were able to provide two umpires for every grade for every Saturday. This means that umpires made themselves available more often and this panel, in conjunction with Queensland Cricket, are thankful to those members.

Maybe in the coming season, we can have the cards for availability in on time and that Queensland Cricket can process them a little quicker. It was very frustrating having to ring around to members on selection night to see whether they were available.

During the 1995/96 season, seventy-nine members officiated in one or more Queensland Cricket Grade games. Due to an increase in the number of clubs participating in First and Second Grade, it was necessary for our Association to appoint sixty-four umpires each Saturday. It was therefore gratifying that not only were we able to allocate umpires to all games throughout the season, there were six occasions when surplus umpires officiated in Sub District games. Numbers ranged from a minimum of three to a maximum of thirteen. The number of umpires who were available for each round were:

The QCA Annual General Meeting was held at the Queensland Cricketers' Club on Tuesday, the 8th August, 1995. The 1995/96 Board of Directors saw only two changes from the previous season with John Keating replacing Brian Sully as Treasurer and Brian Sully replacing Pat Mullins as one of the Vice Presidents.

Congratulations are extended to Barry Richards on having his contract as Chief Executive Officer of Queensland Cricket renewed and to Trevor Hohns on his appointment as Chairman of the National Selection Panel.

The 1995/96 season saw Beenleigh/Logan and Sunshine Coast officially accepted into the Queensland Cricket Association, fielding teams in First and Second Grade of the XXXX District Competition.

One of the major initiatives of the Board was the long awaited introduction of an insurance scheme which came into effect on the 6th October 1995. This scheme covers umpires not only for injuries sustained during the course of play but also for injuries incurred whilst travelling to and from a match.

We were pleased to have our Board Member and Chairman of the Brisbane Grade Committee, Mr Damien Mullins, attend the December Executive Meeting of our Association. As usual Damien was very receptive to our needs and his assistance during the past season was greatly appreciated.

The profile of cricket in Queensland received a major boost with the completion of the new Northern Stand and the introduction of lights and electronic scoreboards. Last season also saw the successful introduction of day/night matches which proved to be very popular with the sporting public.

The QCA has successfully negotiated a thirty year lease of Newmann Oval at Albion. It is planned to use this facility as a venue for the various State training squads and for Second XI games once the redevelopment has been completed. Queensland Cricket administration and coaching staff will be moving to Newmann Oval during the course of the 1996/97 season.

# REPRESENTATIVE MEMBER'S REPORT 1995/96 SEASON

The past season has been a learning process for most Associations.

Following a successful Administration Seminar in Brisbane in August '95, Country Associations have come a long distance in bridging the gap with their city counterparts. With the introduction of Captains Reports; a structure for better working relationships between umpiring/senior cricket bodies; guidelines for judiciary hearings; a Code of Conduct to be incorporated into existing Playing Rules/Constitution; a setting up of coaching/examination/selection panels; Country Cricket should now follow in close footsteps of the QCA structure. I might add, further work needs to be done in some areas and for this reason, a further seminar is set down for 24th-25th August '96 in Brisbane. Country delegates attending need to have necessary communications skills to ensure feedback to their follow Associations.

Country Associations have been quite active in the past season and the role of the Representative Member has been accepted by the zones as their outlet to the QCUA. I am sure that all raised matters have been addressed at some stage by the QCUA. Further to this achievement has been the adoption of this role by the QCCA. The Representative Member attends all QCCA Executive Meetings and addresses such meetings on umpiring activities within zones and any associated problems. This promotes closer relationships between controlling bodies and an acceptance of the umpires' role within the cricketing system.

A Country pool of umpires has been set up and all ten umpires have been exposed to at least one first class country game. Feedback has been forthcoming to Mel Johnson in relation to each umpires performance. This innovation has come to reality and its success is in the hands of Country zones ensuring the umpire nominated is the best available. The Australian Country Trials in Toowoomba in January '97 will utilise at least six umpires from this source. I believe all zones have been adequately serviced with relevant information from the Representative Member and that information provided has been disseminated within the fastest time frame.

Overall, I have seen value in the position of Representative Member and from my point of view, the position is working. The future of country umpires is promising and we must ensure that all umpires in any administrative positions are at all times responsible to their follow members and working for the same goal.
