#### PRESIDENT'S REPORT

It is with great pleasure I present the 1986/87 Annual Report.

This year your Executive Committee has worked to see an increase in our membership, a greater number of our members returning to umpire another season, the final payment made on the training film and completion of the new constitution.

The increase in our active members is due to some hard work done by several members of the Executive Committee and Coaching Panel, also increased activity by the Q.C.A. Recruitment Committee. It is hoped that the Recruitment Committee will continue with the work it started last year to further increase our numbers. I would like to thank their Chairman, Mr. Noel Gorman and his Committee for their thoughtful work and assistance given to our Association.

Improvement in umpiring standards can only be achieved by on field experience thus it was pleasing to see most members from the 1985/86 season return for a further season of umpiring. The retirement of a large number of our members in previous seasons has, in my opinion, been caused in the main by -

- (a) unnecessary pressure being applied; and
- (b) undisciplined behaviour by players towards umpires.

Thanks to the support of the Grade Committee, players are slowly taking a more reasonable attitude towards umpiring decisions. It is hoped that with stronger and more positive support from the Grade Committee and District Club officials the decline in umpires retiring early will cease and more positive help will then be able to be given to our less experienced members. This season our less experienced members were wisely and carefully guided by our observers, Mr. Bob Philippe and Mr. Merv Musch. Our thanks go to them for their untiring dedication and assistance during the season.

The debt owed to the Q.C.A. for the film has been repaid. Our thanks must go to the Q.C.A. for their understanding in this matter. Secondly, our Association owes a great deal to the members of the Coaching Panel and their assistants, whose dedication was largely responsible for the raising of funds to pay off this excellent project. It is hoped that eventually some person in authority will realise the benefit this film can give to umpires in Australia and arrange positive sponsorship to enable the film to be used to maximum benefit throughout Australia.

The new constitution was presented to the Q.C.A. earlier this year and to date, even after several requests, we have not been advised of its progress. Upon its approval it will be presented to our members for their consideration. If our members confirm their desire to move in this direction, a special General Meeting will be held.

I would like to record my thanks to all members of an excellent Executive Committee for their hard work and wise guidance during the year, in particular our Secretary Nelma Grout whose untiring dedication never wanes. I would also like to thank Mr. Col

Bertwistle for his assistance and guidance in several important areas during the year and congratulate Col on being the recipient of this year's Bob Spence Medal.

On behalf of the Executive Committee, I would like to record their appreciation to the Q.C.A. office staff, the Grade Committee, and the Q.C.A. Executive for their assistance. The Executive would also like to express their gratitude to the Allocation Committee, Coaching Panel and Social Committee for their dillegence and dedication throughout the year.

#### COLIN TIMMINS

#### LIFE MEMBER - 1986

At the Seventeenth Annual General Meeting, Nelma Grout was made a Life Member. Daughter of Wally Grout, Australian wicketkeeper for many years, Nelma has been involved with cricket from a very early age and subsequent to joining the Association in August, 1975, became the first lady umpire in Australia to officiate at First Grade level in January, 1977.

Nelma, who holds a First Grade Badge, umpired for nine seasons. She has not participated on field since 1984 due to the arrival of her two children, Geraldine and Wallace.

Since 1979, Nelma has continually served on the Executive Committee, during which time she has been Secretary for seven years, was a member of the Social Committee for many years and has been Chairperson of the Allocation Panel during the 1985/86 and 1986/87 seasons.

In addition to her involvement with the Umpires' Association, Nelma was involved with the Queensland Ul9 organisation from 1978 to 1981.

Although the strain of family involvement coupled with the demands of her administrative responsibility to the Association must at times have become difficult to overcome, the dedication and enthusiasm she has continually displayed typifies the person who we now congratulate as our new Life Member.

#### COL BERTWISTLE

#### EXECUTIVE REPORT

The Executive Committee met on 13 occasions and attendances were as follows:

C. Bertwistle (12), N. Grout (13), L. Heath (12), J. McPhee (10), M. Musch (11), P. Parker (11), D. Payne (13), R. Petri (5), M. Ralston (5), C. Timmins (12).

New members to the Executive Committee for 1986/87 were Don Payne and Roger Petri. Due to study commitments, Roger Petri was forced to resign and Mike Ralston was elected in February as the new Executive member.

In May each year, members of the Executive Committee meet with the Brisbane Grade Committee. As a result of our meeting with the Grade Committee in 1986, the Q.C.A. again agreed to reimburse umpires for their hats and our allowances will in future be reviewed annually. Umpires' allowances were increased to \$28.00 with a partner and \$33.00 alone for the 1986/87 season.

The topics which members of the Executive Committee discussed with the Grade Committee this year were well received. Some items discussed were: that markings for the "danger area" be shown on all pitches; there be a fixed amount reimbursed to umpires towards the purchase of their hats; that Gabba Sporting Products games follow the same rules as the McDonald's Cup; the inconsistencies in the handbook and that spikes will be worn by players in First and Second Grade in the 1987/88 season.

The main achievement of the Association for 1986/87 was the repayment of the loan to the Q.C.A. At the beginning of this year \$3,000.00 was still outstanding but thanks largely to the extremely hard work of the Examination and Coaching Panel giving seminars, the loan was repaid by the end of 1986.

The main project of the Executive Committee this year has been to draft the consitution for the Queensland Cricket Umpires Association. The Q.C.U.A. Constitution was written by a subcommittee with assistance from our Honorary Solicitor, Mr. Basil Wright. Upon completion, the draft Constitution was sent to the Q.C.A. for their approval. Upon approval from the Q.C.A. and our members, a Special Meeting will be called so that we can become the Queensland Cricket Umpires Association during the 1987/88 year.

Throughout the year, there has been continued discussion on insurance for umpires. At the October General Meeting, members decided not to renew our present insurance policy. Since then, the Executive Committee has been looking into Public Liability Cover for the Association.

For the first time, all members received newsletters this year. The purpose of the newsletter was to keep members informed about what was happening within the Association and Q.C.A. District Cricket. It is hoped the newsletter "Black and White" will continue in the forthcoming season.

Another innovation during the season was the introduction of members wearing name badges to meetings. Thanks are extended to Mr. Lachmund for providing the badges and tape and to Mr. Musch for printing the names.

The 1986/87 season saw more Country Associations requiring examination papers and inquiring about umpiring courses. Therefore, it was decided that a correspondence course be written. The Examination and Coaching Panel has this task in hand.

Finally, our thanks go to the Q.C.A. and their staff, the Brisbane Grade Committee and the Conducts Committee for their assistance and co-operation throughout the year.

#### BOARD OF EXAMINATION AND COACHING

This year's panel was extremely active and we believe had a very successful year.

The panel would like to extend thanks to all members for their assistance in helping with seminars which were a major contributor in paying off the loan from the Q.C.A. Seminars were given for Zone 4 Junior Division, Pine Rivers Cricket Association, the Gold Coast Second Division and two seminars were given for both Church Union and Women's Cricket.

Every season the number of seminars this panel gives has increased. So that members of the panel can be easily identified, the Association bought them shirts to wear when giving seminars.

The panel held a pre-season seminar for new and prospective members on the 6th September. This was attended by 15 prospective umpires and a number of senior umpires who assisted the panel with the seminar.

Prior to the commencement of the season, the panel met with First and Second Grade umpires to explain Regulation 19 regarding 96 overs. During the season we held discussion and coaching sessions at each monthly meeting with the seminar/refresher exam occurring at the October General Meeting. We hope that all members received some benefit from our monthly sessions.

The Examination and Coaching Panel would like to once again thank members for their support and wish everyone a successful 1987/88 season.

#### THE BOB SPENCE MEDAL

A subcommittee of Col Bertwistle, Peter Parker and Merv Musch was formed to recommend any changes that needed to be made to the allocation of points towards this medal. For the 1986/87 season the changes made were:

- \* members receive one point for the seminar/refresher exam which are held conjointly.
- \* different marks were allotted to the A F ratings.
- \* ½ point to be given if an umpire stands in two Sunday games and one point if an umpire stands in at least four Sunday games including First Class and Special Q.C.A. appointments.
- \* when a captains' report is not received, umpires will receive the average mark of that round.

As the Bob Spence Medal is only in its third year, there are still teething problems and during the off season, a few small changes have already been suggested for the Rules of the 87/88 season.

Thanks are extended to John King and his wife Narelle, for collating the statistics for the award. The collation of these points took a great deal of time and effort and was greatly appreciated by the members.

At the Umpires' Annual Dinner, the top ten contenders namely Col Bertwistle, Mick Harvey, Phil Latimer, David McGrath, Tony McQuillan, Peter Parker, Don Payne, Brian Pumfrey, Mike Ralston and Neville Scholes were announced by our President. This was followed by the presentation of the Medal by our Patron, Mr. Bob Spence to the winner, Col Bertwistle. The Association congratulates Col on winning the award.

Col Bertwistle rejoined the Association in the 1983/84 season. He was a member of the Umpires' Association some years ago before being transferred to the country with the ANZ Bank. On his return to umpiring, Col very quickly progressed to First Grade and has already been awarded his First Grade Badge. In the 1986/87 season, Col was appointed to umpire the Gabba Sporting Products Final. Col is also heavily involved in the administration of the Association, being a member of the Executive Committee for two years, a member of the Social Committee for the 1984/85 and 1985/86 seasons and was appointed to the Allocation Panel for the 1986/87 season. Mr. Bertwistle is a worthy winner of this Medal.

#### **MEMBERSHIP**

The 1986/87 season was very successful with regard to membership. The total membership was sixty-seven which includes our eight Life Members. Eighteen new members joined the Association during the season which was an increase of eight on the previous season.

Of our members, fifty-five officiated in one or more games. The percentage of active members and the average numbers of umpires per round (39.5) has again increased which is very pleasing. In previous seasons, it has been difficult to give all Sunday games a full compliment of umpires, but this was achieved in the 1986/87 season with twenty-three umpires officiating in the Gabba Sporting Products Competition and twenty-five members officiating in the Under 19 Competition. Thanks are extended to those umpires who were available for Sunday games. Congratulations and thanks are also extended to nine members who officiated in all Q.C.A. fixture rounds. The average mark for the 1986/87 season was 6.3, just slightly below a C rating.

Congratulations are extended to Peter Parker on making his First Class debut this season and to Tom Richardson, Don Payne and Bruce Edmunds on making their First Grade debuts.

Brian Turner, George Durston and Neville Scholes were presented with their First Grade Badges for having officiated in twenty-five First Grade games. There are now nineteen members who have achieved this milestone, thirteen of whom are still umpiring in the Association.

Nine members plus the eight Life Members have been in the Association for at least ten years. On behalf of the Association, we congratulate these members and thank them for their contribution to date and look forward to their continued involvement with the Association.

Thanks must be extended to Tony McQuillan for his "Over Calculator". Tony produced an over ready reckoner for First Grade games and also for the other Grade games. Tony's efforts were greatly appreciated by all members.

Our members were asked to officiate at several games and carnivals throughout the season, including pre-season trial games, a six-a-side competition at Norths, the Ul9 trials, Ul7 Elite Squad games, age trials for Zone 4, the TAB Carnival and the Intra State Primary Carnival. Our Association also was able to assist the Queensland Womens' Cricket Association by officiating in some of their knock-out games and their Finals.

Congratulations are also extended to the following members: Steve Lanigan on his marriage in September, 1986 and to Nelma Grout on the birth of her second child.

#### SOCIAL COMMITTEE REPORT

Although the number in the Social Committee was reduced to three by the end of the season, this Committee was very successful both socially and financially.

At the commencement of the season, the Committee set a target of \$750.00 to raise during the season and achieved this. The greatest fund raiser was a Gold Lotto Draw which ran over eleven weeks. All 45 numbers were sold at \$20.00 each. The Gold Lotto Draw yielded \$400.00 profit. The other main avenues for funds were through running raffles at the monthly General Meetings and the Christmas Hamper Raffle. Thanks are extended to members who donated to our raffle prizes because without these donations our funds would not have been so healthy.

On the social side, the Committee organised a number of functions, some better attended than others. The pre-season barbeque at Sherwood Forest unfortunately was only attended by 17 people.

The most successful function was "Breakfast with the Stars" at the Cricketers' Club at which 76 people were present. After a sumptious breakfast, members spent an enjoyable day watching the cricket from the Cricketers' Club.

A Christmas Party in the form of a barbeque was held at Nelma's place and attended by 40 people. Santa Claus arrived with gifts for the younger children. Thanks are extended to Don Payne for being Santa Claus in adverse weather conditions. To the wives, Eunice, Pam and Lorraine thanks for the delicious food.

The highlight of any season is the End of Season Dinner which this year was held at Lennons Hotel and attended by 60 people approximately. Everyone at the dinner enjoyed excellent buffet meal and free drinks for only \$25.00.

The 8th March saw two functions organised - a Golf Day at Tweed Heads Golf Club and our Annual Cricket Match againt Valleys. Due to bad weather conditions, the Golf Day had to be cancelled but the Cricket Match went ahead. Members old and young played in the Umpires' Team but regrettably, we were again defeated by Valleys. Thanks Valleys for the hospitality extended to our members.

Thanks are extended to the members of the Social Committee for their excellent work and also to members for their attandance at functions and their support.

#### UMPIRES' ALLOCATION PANEL

This panel was kept busy throughout the 1986/87 season allocating umpires to the Metropolitan v Country Colts game, twelve Q.C.A. fixutre games, seven Gabba Sporting Products games and five U19 games as well as Semi-Finals and Finals.

As in previous seasons, umpires were allocated to games on a round by round basis. This season, in addition to notifying the Q.C.A. by completing your allocation card, members were asked to contact the Panel Chairman of their availability if they had not officiated in the previous round. This system worked well. Unfortunately there is still a small minority of umpires who are not informing the Q.C.A. by the specified time and therefore can only be allocated where there are vacancies.

In the first nine rounds, umpires in the lower Grades were rotated so that all Grades were receiving the benefit of umpires during the season. For the remaining three rounds, umpires were appointed to the crucial games in every Grade. The players appreciate this method of allocation.

Life was made slightly easier for the panel this season because more umpires were available each round and for the Sunday games. The Allocation Panel would like to thank members for their commitment to umpiring especially to those umpires who were available for all Q.C.A. fixture and Sunday games.

The umpires' observers worked closely with the panel and their comments were very helpful.

Sincere thanks are extended to Ian and Christine at the Q.C.A. for their assistance throughout the season.

#### UMPIRES' RECRUITMENT COMMITTEE

The members of our Association on this Committee were Colin Timmins, John McPhee, Peter Parker and Jim Taylor.

As a result of a meeting held in August, it was decided that an article about umpiring would appear in "Cricklet" as well as placing advertisements for umpires in the Telegraph, the Sheffield Shield programme and on 4BC.

In addition, district Clubs were asked by the Q.C.A. to forward the names and addresses of retired players to our Association so that they could be contacted with regard to umpiring. Unfortunately only Wests and Valleys replied to this request and despite these responses no umpires were recruited by this method.

The Q.C.A. allocated \$600.00 for the recruitment of umpires this season. For this, we are most appreciative.

#### QUEENSLAND CRICKETERS' CLUB

The Association would like to express its sincere thanks to the management and staff of the Club for their assistance throughout 1986/87. We are most appreciative of the Club's gesture in allowing the Executive Committee the use of the library for our meetings.

This year, members and friends enjoyed a breakfast on the patio of the Cricketers' Club and were given free admission to the Club to view the cricket for the day. For this, we are very grateful.

The facilities of the Club are always available to our members on meeting nights throughout the year. Our continued support in this area will be well received by the Club.

#### OBITUARY - ALLAN MOORE

It is with regret that we record the passing of Allan Moore.

Allan had only been a member of the Association for two seasons. At the completion of his first season, Allan was umpiring Third Grade games and in the 1986/87 officiated the whole season in Second Grade. He was also appointed to his first Gabba Sporting Products game in the 1986/87 season.

In the 1986/87 year, Allan was a valuable member of the Social Committee and was in charge of organising the successful End of Season Dinner. His efforts will be sorely missed.

## AUDITOR'S REPORT

I report that I have examined the attached Income and Expenditure Account and Balance Sheet which have been prepared in accordance with the convention of historical cost accounting. It is not practicable for the Association to establish accounting control over all sources of income prior to its receipt and accordingly it is not possible for my examination to include audit procedures to extend beyond the amounts of receipts recorded in the account records of the Association. In my opinion, monies recorded as receipts have been properly accounted for by the Association.

Subject to the foregoing, in my opinion, the Balance Sheet fairly represents the financial position of the Association as at 30th April, 1987 and the Income and Expenditure Account fairly represents the results for the year then ended as disclosed by the books of account.
