



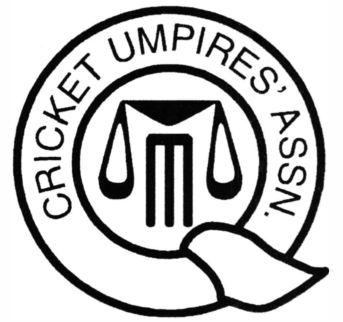

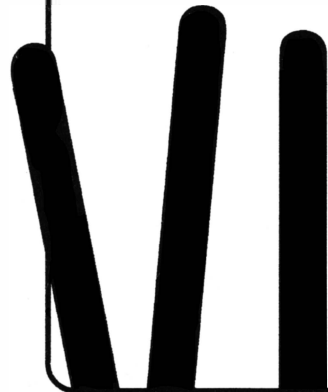

Mrs Joan Burge and son John were welcome guests at our Annual Dinner, where Mrs Burge presented the awards to the finalists and winner of the Bob Spence Medal, a role Peter had performed for many years.

With Peter's passing, we welcomed Mr Allan Border as our new Board Member, and Mr. Ron Archer as the new Conduct Commissioner.

While space will preclude mention of many deserving people, Don White cannot be overlooked for another big year at the head of the social committee. Don and his committee are there at every meeting, selling drinks, flogging raffle tickets and generally making our meetings so much more pleasant. Well done, you blokes!

Commendations also to Judy Harris and friends who continue to train and encourage people in the Gentle Art of Scoring.

Many thanks to all members of the Executive for their contributions throughout the year. There was often debate on matters of import, but I am pleased to think that generally, final outcomes were in the best interests of our members.

Lastly, thanks to all members for your interest/support/criticism through the year. In the season ahead I urge you all to stay interested and involved in the affairs of your association. Remember, decisions are made by people who turn up!

## EXECUTIVE COMMITTEE REPORT

The year 2001-02 welcomed Ross Howard and Gary Fazen to the Executive Committee, with all other Executive positions unchanged. The Association wishes to thank long serving Executive Committee members, Ray Isherwood and Alan Loynes for their many years of service in this capacity. The Committee met monthly to conduct the business of the Association. The main items of business discussed were:

### Queensland Cricket Strategic Plan

Early in the season our Executive met with the Queensland Cricket Board to continue discussions on where other Umpires' and Scorers' Associations should fit in the structure of the Queensland Cricket Umpires' and Scorers' Association. As a result, a sub committee was formed to gather the names and addresses of umpires throughout Queensland for insurance purposes and also to obtain an up to date record of Office Bearers. Secondly, a questionnaire was distributed to ascertain what the Country Associations wanted in a restructuring and what their relationship was with their relevant Cricket Association. Any information we received was passed onto Queensland Cricket for their consideration. It is hoped that during the 2002-03 year, slight modifications will be made to our Constitution to better reflect the position of other associations within our structure.

### Reserve Observer

Queensland Cricket agreed to our Association having a reserve observer who would be used when one of our regular observers was unavailable. By consistently having three observers, this allows for our members to be seen more often, which can only improve our umpiring.

### Name Badges

All new members and any other members who wanted them were given plastic name badges. This initiative allows umpires to wear these badges to meetings and more importantly while they umpire.

### Test Umpires' Reunion

Our Association was happy to assist financially any of our Test umpires who attended the Reunion in Sydney in January 2002.

### Associate Members

The Executive welcomed all umpires of the Sub-District Umpires' Association as Associate Members of our Association. The Sub-District Association has worked closely with us over the last five years and when possible any excess umpires would officiate in the Sub-District Competition. We also allocate some of our members to their finals.

### Property

Our property officers, Greg Cubit and Steve Dean, were kept busy throughout the season selling merchandise at our general meetings and also sending merchandise to the country. New styles of casual polo shirt and cap were introduced and proved very popular with our members.

### First Aid Course

To improve our umpires' ability to respond to an onfield emergency, the Association is offering the members the opportunity to do a First Aid course during the off season. Queensland Cricket has recommended this course to members of District Clubs.

### Annual Subscription

In the forthcoming season, Queensland Cricket has agreed to offer the facility which will enable umpires to authorise Queensland Cricket to deduct the umpires' annual subscription from the first instalment of their allowance. This will make it easier to collect the subscriptions and eliminate umpires having to worry about paying their subscriptions on time.

## MEMBERSHIP

The 2001-2002 season saw our Association with **115** members, comprising **13** Life Members, **91** Ordinary Members (**10** Scorers and **81** Umpires) and **11** Associate Members. It was pleasing to welcome umpires from the Sub-District Association as Associate Members.

Although our membership numbers appear healthy, there were only 79 members who officiated in one or more games when 72 are required every Saturday. Our recruiting was not as successful as hoped, with only 15 new umpires joining our ranks and unfortunately 16 umpires, including a number of experienced umpires, did not renew their membership.

## ASSOCIATION AWARDS

The Grade Awards are given to the umpires who achieve the highest average score from the captains in the grade they have officiated the majority of games in. In addition, the Col Hoy Encouragement Award and Alan Pettigrew Progression Award are given to the most promising new umpire and to the umpire who has shown the most improvement respectively.

Mr Mel Johnson, Director of Umpiring, announced the top contenders and winner of each award. Mr John McKnulty, President of Queensland Cricket, Mr Roger Harris and Mrs Bev Hoy presented the respective winners with their awards.

**The Wep Harris Award for First Grade** - The contenders were Lawrie Musch, Bruce Oxenford, Jim Torpey and Jim Veivers. The winner was **Lawrie Musch** who is an experienced First Grade Umpire, holder of a First Grade Badge and on the First Class Panel. He was only able to officiate in seven First Grade games due to First Class commitments.

**Second Grade Award** - There was strong competition for the award in this grade. The contenders were Peter Boland, Andrew Bonner, Andrew Curran, Alan Loynes and Jim Tobin. The winner was **Andrew Bonner** who is in his 4<sup>th</sup> season of umpiring and 2<sup>nd</sup> season in this grade. He officiated in all matches with nine of these in Second Grade.

**Third Grade Award** - The contenders were Jack Ezzy, Peter Monaghan, Geoff Thompson, Don White and Iain Wyeth. This award went to **Geoff Thompson**, a very experienced umpire who joined our Association in 1995. This season Geoff officiated in every round including eight in Third Grade.

**Fourth Grade Award** - The top contenders were John Foster, Jay Kangur and Peter Johnson. The award went to **Peter Johnson** who is officiating in only his second season. He stood in nine Fourth Grade matches.

**Fifth Grade Award** - The contenders were Evan Biggs, George Durston and Chris Pritchard. The winner was **George Durston** who returned to umpiring this season after an absence of a number of years. George officiated in all games, ten in Fifth Grade.

**Under 18 Grade Award** - The contenders were Ross Brown, Michael Clarke and Peter Lindsay. The winner was **Ross Brown** who is an experienced member of five years. Ross prefers to officiate in the U18 grade where he is highly respected by the players. He officiated in ten games.

**Alan Pettigrew Award** - The winner was **Damien Knott** who is in his first season with our association having previously umpired in Canberra. Damien, who officiated in all grade matches began in Fifth Grade, did six games in Fourth Grade and then four games in Third Grade.

**Col Hoy Award** - This award is donated by the Cricket Society in memory of former Test umpire, Col Hoy. This year, the winner was **Shane Vetsich** who had a successful first season. He officiated in ten grade matches, three in U18, two in Fifth Grade and five in Fourth Grade.

## BOB SPENCE MEDAL

## **DIRECTOR OF UMPIRING REPORT**

As stated last year, Tony Crafter retired and he has been replaced by Geoff Allardice who basically looks after the umpires' performances, Brent Silva who looks after travel and accommodation for the umpiring fraternity, and Peter Hanlon who is responsible for the Accreditation Scheme.

Umpires at First Class level have had good support in the way of verbal and written appraisal of their efforts by Geoff Allardice. His support network includes the State Directors and coaches/mentors.

Peter Hanlon has worked tirelessly to finalise all aspects of the National Accreditation Scheme. Accreditation of Level 2, i.e. all umpires who are affiliated with a cricket association, will be available from August 1st 2002. In accordance with the Sports Commission ruling, unfortunately there will be no recognition of prior learning, i.e. all members will be required to complete the whole course. Level 1, aimed at junior coaches/managers who umpire their games, school teachers and player/umpires will be phased in during late 2003.

During the latter half of the 2001-02 season, the ACB directors voted to inaugurate a National Umpires' Selection Panel. Allied with this were three panels of ACB contracted umpires. The three panels are: National Panel, Supplementary Panel and Development Panel. Although both these initiatives will benefit umpiring in general, they have the drawback of narrowing the chances to get to the top. Maybe State Associations (as some have already done) should place a greater emphasis on and reward for First Grade.

In the ever changing face of umpiring during the early part of this decade, Country umpires and their Associations allied with QCU&SA will be undergoing changes in line with Queensland Cricket's Strategic Plan. This change will be mostly cosmetic with all Associations retaining their autonomy to a great extent.

In a further breakthrough for Country umpires (who incidentally stack up very well against their city counterparts), selected umpires were invited to our seminar on the Sunshine Coast. In a first for Australia, the Australian Country Cricket Championships to be held in Bundaberg early 2003 will be umpired by Country umpires only. To put the "final polish" on them, the QCCA is assembling some thirteen umpires for a specialised seminar in Brisbane.

The job of the State Director is made so much easier by the great support from QCA, the QCCA and the ten zone contacts. These ten men have been instrumental in placing Queensland as an umpiring state way up there in Australia.

My thanks go to all those people mentioned before and the many who support me in various ways.

## **UMPIRES' MENTOR (COACH) REPORT**

It was an honour to be appointed Mentor (Coach) of the First Class and Supplementary Umpires by Queensland Cricket.

Part of my job was to attend all Pura Cup and ING Cup fixtures played at the Brisbane Cricket Ground to observe and report on the performances of the relative umpires. The supplementary umpires were also observed at fixtures played at Alan Border Field.

How times have changed from my time as an umpire to the present day. There was no feedback on performances. You were never involved or privy to Captains' Reports.

Now the umpires, captains and coaches attend a meeting chaired by a facilitator, where any contentious decisions can openly be discussed. When the umpires and coaches have left the meeting the facilitator will be told by the captains the umpire's rating 0 – 10.

This report is then sent to the ACB Umpires' Manager, who collates the reports with those sent in by other State Associations for fixtures played in their State. I also have to report my ratings of the umpire's performance.

At the end of each fixture I receive from Queensland Cricket a computer disk of all appeals, play and misses etc that occur during the game. I am then able to analyse the decisions made and spend time with each individual umpire on whether or not they have made the correct decision.

If after a day's play an umpire is concerned about a particular decision he has made. I have the facility with the technology available to view the decision in question and inform the umpire of my interpretation.

My congratulations are extended to all members of the panel who achieved and maintained a very high standard throughout the season.

Congratulations are also extended to Greg Cubit who was appointed to the First Class Panel and who performed very well in all his appointments.

Congratulations are also extended to Jim Veivers on his appointment to the Supplementary Panel. He also had a very credible season.

Listed later in the Annual Report are the fixtures that each panel member was appointed to during the season.

## **QUEENSLAND CRICKET ASSOCIATION**

John McKnoulty, long serving President of Queensland Cricket was made a Life Member.

Congratulations to the Queensland Bulls who this year won the Pura Milk Cup for the third consecutive year. Queensland Bulls continued their dominance as the only state to win the Pura Milk Cup.

Queensland Cricket has spent considerable time during 2001-2002 making amendments to their Constitution which included the restructuring of the Queensland Cricket Board.



The Queensland Cricket Umpires' and Scorers' Association is greatly appreciative of the support given to us by Queensland Cricket. In 2001-2002, Queensland Cricket established the position of Umpires' Mentor, charged with the task of coaching the First Class Umpires. The Board decided to pay the full amount of all umpires' allowances rather than requiring the Clubs to contribute. Queensland Cricket also took over responsibility for all insurance premiums for players and umpires. These decisions helped the clubs and our Association financially for which we are very grateful. Our Umpires also had their allowances increased by \$10.

To assist Queensland Cricket in making an award to the best groundsman, the umpires allocated points for the condition of the ground and pitch at the completion of each round.

On the Grade scene, the hours of play in the lower grades were changed slightly to bring their cessation time closer to that of First and Second Grade. Also a new competition was introduced for Over 40s. Six district clubs played in this competition.

Thanks must be extended to all Queensland Cricket staff, especially to Ian Sturgess, Manager of Grade Cricket, and Graham Dixon, General Manager, for their assistance throughout 2001-2002.

**PETER BURGE** *May 17, 1932 – October 5, 2001*

Our Association lost a good friend and supporter when Peter John Burge died suddenly while holidaying on the Gold Coast in October 2001. Peter, widely regarded as Queensland's finest home-grown batsman, passed away at the age of 69.

He had been a Director of Queensland Cricket since 1994-95. Peter held the portfolio of 'Cricket and Umpires' on the Board, was the Conducts Commissioner and also was an International Referee.

He was a Life Member of Queensland Cricket, the Brisbane Cricket Ground Trust and Eastern Suburbs Cricket Club. In 1990-91, our Association in conjunction with Queensland Cricket introduced the Peter Burge Medal, which is presented to the best and fairest grade player annually.

Burge played 42 Tests for Australia, 91 First Class matches for Queensland and 233 First Class matches in a career that spanned from 1952-53 through to 1967-68. He captained Queensland on 28 occasions and was named in 2000 in the Queensland Cricket Team of the Century.

Peter Burge was appointed a Member of the Order of Australia (AM) in 1997. He is survived by his wife Joan, two sons Hugh and John and grandchildren.

## PETER BURGE MEDAL

For the first time in the history of the medal, a Wests player was the winner. Greg Rowell, who captained Wests into the Final of this season's XXXX Grade Competition against premiers Sandgate-Redcliffe, won the Medal by three votes. Rowell also claimed the bowling averages award, finishing with 27 wickets at 11.92. He retired from First Class cricket after the 1998-99 season following a career where he played for NSW, Queensland and Tasmania and represented Australia 'A'.

Joan Burge, Peter's widow, and son Dr Hugh Burge presented Greg with the medal and perpetual trophy at the Annual Grade Trophy Presentation Night, which was held in the Legends Room at the Gabba.

The other top contenders were Steve Paulsen, the 20 year old leg spinning allrounder who made it a Wests quinella by finishing on 16 points, ahead of 19 year old Sunshine Coast opening batsman Aaron Maynard (14 points) and Wynnum-Manly pace bowler Boyd Williams and Souths batsman Michael Sippel.

#### **Note 1: Accounting Policies:**

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Queensland Cricket Umpires' and Scorers' Association's Inc. constitution to prepare accounts. The Executive Committee has determined that the Association is not a reporting entity as defined in *Statement of Accounting Concepts 1 "Definition of Reporting Entity"*. Accordingly there is no requirement to apply accounting standards in the preparation and presentation of the report.

Consistent with prior years the Executive Committee has used the cash basis of accounting with additional recognition for the depreciation of the Association's fixed assets. The cash basis of accounting means that income is recognized when cash is actually received, not when it is due to be received, and expenses are recognized when the payments are made rather than when a liability exists.
