


PRESIDENT'S REPORT

Another season is completed, and I have great pleasure in presenting the Annual Report for the 1994-1995 Season.

The twenty-sixth season has indeed been a great success. Our membership is at it highest for many years and the spirit within the Association is a credit to all members. It has been a long time since the Association was able to field a full compliment of umpires in all rounds. This season we almost succeeded. The challenge for the coming season will be to have two umpires stand in all fixture matches, and as a result supply as many umpires as possible to the Second Division Competition. This will be no easy task. The introduction of the Beenleigh - Logan and Sunshine Coast clubs will tax the existing supply of umpires. I am also confident that the Recruitment and Development Officer with the help of the Examination and Coaching Panel will achieve this objective.

As all members would know by now, I have accepted a position in North Queensland and regrettably am unable to stand for re-election. I would like to thank all members for the support and the involvement they have given to the Association. In particular the members of the Executive and especially to Nelma Grout for the time and effort she puts into the job of Secretary and to Phil Latimer for the way he has handled the finances of the Association.

The 1994-1995 Season was one of steady growth and consolidation. On the field, congratulations to our test umpires, Tony McQuillian, Peter Parker and Colin Timmins for their appointments during the season. For Peter it was an outstanding year of appointments highlighted by his appointment to his second test match and to the historic shield final. Congratulations to Ray Isherwood and Wayne Heinemann who were joint winners of the Bob Spence Medal. Particularly to Wayne who is the first winner who is not from the first grade ranks. It was also great to see the cross section of members achieving the top ten places, congratulations to all.

Congratulations also to Jim Torpey and Glenn Zimmer for their appointments to the Under 17 and Under 19 Australian Championships and to those members who were appointed to officiate in the many semi-finals and finals in the different competitions.

These successes can be attributed to the work of the Examination and Coaching Panel under the guidance of Mel Johnson and to the effort and time given by Col Bertwistle to the new members. Our thanks to both of you and to all members of the Examination and Coaching Panel.

I would also like to acknowledge the support given by Queensland Cricket. In particular the assistance given by Damien Mullins from the Board of Directors and Ian Sturgess and Graham Dixon from the administration.

The continuing successful communication and rapport with the other umpires' associations can be directly attributed to the involvement of the Representive Member and his role on the Executive. Thank you to Wayne Petersen for the work he has done in this role.

The financial success of the Social Committee was second to none. Their efforts and enthusiasm were incredible and must be commended. Our thanks to Wayne Heinemann, David Walker, Noal Southall and Darryl Vinall.

Finally I would like to thank all members, not only for their support during the season but also during the past 12 years of my involvement. I intend to continue my involvement with cricket umpiring in Townsville, and continue the many friendships I have made through the Association.

LIFE MEMBER

Mr Col Bertwistle was awarded Life Membership of the Association at our Twenty-Fifth Annual General Meeting on the 3rd August 1994. The number of members who supported the nomination is indicative of the high esteem in which Col is held by his peers.

Col returned to umpiring with the Q.C.U.A. in 1983/84 after an absence of 15 years due to work commitments. He has been heavily involved in the Association since 1983 both in the practical and administration fields.

In relation to the latter, Col worked extremely hard on the Social Committee during the first two years, has held a position on the Executive Committee for 9 years, Grade Allocation Panel for 8 years and the Board of Examination and Coaching for 6 years. During the latter two years, he has been a member of the First Class allocation panel and in 1990/91 was instrumental in implementing the successful recruitment and development programme.

An umpire who is held in high esteem by all First Grade players, Col is a holder of the 'A grade' and '100 game' badges, winner of the 'A grade' achievement award in 1994/95 and the Bob Spence Medal winner in 1987 and 1991. Over an 11 year career in grade cricket, it is commendable that Col has been only unable to officiate in a minimal number of games which demonstrates his commitment to the game.

Col was a member of the First Class panel for 5 years from 1988 to 1993 and officiated in 12 Sheffield Shield games, 4 domestic One Day games and two Queensland games against Sri Lanka and the West Indies.

The Queensland Cricket Umpires' Association is indebted to Col for his contributions on and off the field to the Association and congratulate him on an honour well deserved.

EXECUTIVE COMMITTEE REPORT

For the 2nd successive year, our Association was very ably led by Paul Polkinghorne as President and Ray Isherwood as Vice President. Long-serving member of the Executive Committee, Mike Ralston did not seek re-election and his vacancy was filled by Alan Loynes. Thanks must be extended to Mike for his contribution over many years.

The Executive Committee met on 11 occasions during the year under review and attendances at these meetings are indicated below:

The main items of business handled by the Executive Committee are as follows:

Excess Umpires - Prior to the commencement of the 1994/95 season, negotiations were concluded between the Q.C.U.A., Q'ld Cricket and Second Division. Q'ld Cricket agreed to finance one umpire from our Association per game. The system of rotating excess umpires into Second Division has been beneficial to both Associations and we look forward to continuing this policy in future seasons.

Umpire Recruitment - The Executive Committee supported the format of holding a weekend seminar in Brisbane for new umpires. This was attended by a total of 15 people which included first year members of the previous season.

Sunglasses - In accordance with A.C.B. policy, it was agreed that umpires be allowed to wear sunglasses while officiating. The Association would like to thank Ian Elcock Optometrists for their kind offer of 20% discount to any umpire purchasing glasses from them.

Bob Spence Medal Rules - This season, the Executive Committee reviewed the Bob Spence Medal Rules and have applied a more equitable policy with strict guidelines. Written apologies will no longer be acceptable for non-attendance at meetings. While reviewing such guidelines, the Executive Committee remained conscious of the views expressed by members at general meetings.

Badges - New badges were approved in recognition of umpires who had officiated in excess of 150 and 200 games. To achieve this objective of 150 games, an umpire would be required to officiate for a minimum of 13 seasons. Quite an achievement.

Grant Subsidy Scheme - Queensland Cricket requested our recommendations on the continuation of the Grant Subsidy Scheme which they were reviewing after the initial three year period. Subsequent advices have confirmed that the terms and conditions for the ensuing three years will be identical to that previously enjoyed. In essence we shall receive up to \$30,000.00 over the next three years.

Accreditation For Junior Umpires - The Secretary attended a meeting of the Queensland Junior Cricket Association and was involved in discussions on the possibility of 15 and 16 year olds becoming accredited as umpires to officiate in carnivals held in the country. The Q.C.U.A. supports this initiative and would be happy to assist with exam papers and accreditation.

President's Allowance - Due to an increasing number of visiting umpires from interstate and overseas, it was decided that the President receive an allowance of up to \$350.00 per year for entertaining these dignitaries on behalf of the Association.

MEMBERSHIP

The Association has continued to steadily increase its membership. An analysis of our membership is listed below with the previous year's statistics shown in brackets.

Due to successful recruitment, we continue to attract new members. Following our pre-season advertising, 10 new members began the season and after additional advertising, a further 7 members began mid season.

Unfortunately, although we continue to gain new members, each season we also lose members for various reasons. In 1994/95, 17 members did not renew their membership of which two-thirds would have officiated in some capacity the previous season. In addition, approximately 8 members began this season but because of work transfers, business/family commitments and health reasons were unable to officiate more than a few rounds.

For the second successive season, Messrs McQuillan, Parker and Timmins were named on the National Panel. Congratulations on this achievement. Tony and Colin officiated in the Benson and Hedges World Series Competition, while Peter in his most successful season to date, was appointed to one Test Match, 5 World Series games including a final, the Mercantile Mutual and Sheffield Shield Finals.

During the off season, Colin Timmins announced his retirement from all levels of umpiring. But it is pleasing to report that Peter Parker and Tony McQuillan have retained their positions on the reduced National Panel for 1995/96. Our Association is extremely proud of the achievements of these umpires and wish them every success in the forthcoming season.

Sincere thanks must be extended to Tom Warwick, a Life Member of our Association, for compiling the history of First Class umpires in Queensland. Tom agreed to complete this task for the Association a

few years ago and after many long hours and extensive research, Tom has given the Association a very comprehensive document on the statistics of all Queensland's First Class umpires which can now be updated each season. Your efforts are greatly appreciated.

In addition, to all Q.C.A. games, the Association was happy to supply umpires to numerous games and carnivals, some of which include Cricket V Cancer Charity Day, the Christian Brothers' carnival, Suncorp Cup games, Interservice carnival, Independent Schools carnival, TAS games, numerous games organised by the Queensland Cricket Coaching Department and the finals of the Second Division and Redlands Cricket Association.

COLIN TIMMINS - RETIREMENT

After 18 years of umpiring, Colin has announced his retirement from all levels of umpiring. During his career Colin officiated in approximately 180 Q.C.A. fixture games. His first class career began in December 1981 and since then he has officiated in 4 Test matches, numerous World Series games and over 100 matches involving the Queensland team which includes 50 Sheffield Shield matches. To conclude his career, Colin was the first video umpire in a Shield game and he has the distinction of being the first to dismiss a batsman (J. Brayshaw - run out) in a Shield game.

The Association congratulates Colin on a very successful umpiring career.

BOB SPENCE MEDAL

In the 11 year history of this award, this year is the first time there has been joint winners. When one considers that the winner is determined on the basis of points allocated for attendances at general meetings and seminars, doing a refresher exam, the number of Saturday and Sunday games umpired and your average mark for umpiring, the result is quite astonishing.

At the Dinner on the 1st April, our Board Member and Chairman of the Brisbane Grade Committee, Mr Damien Mullins presented dual winners, Ray Isherwood and Wayne Heinemann with the Bob Spence Medal for Umpiring Achievement for 1994/95.

Ray, a very experienced and respected former Test umpire, won the award for the second successive year. He is currently Vice President of the Association.

Wayne joined us in 1992/93 and in that season won the First Season Encouragement Award followed in his second year by winning the Special Category Award. The above performances indicate that Wayne has the potential to progress to higher appointments in the future.

Kevin Horton, Ross Howard, Alan Loynes, Tony McQuillan, Mark Molesworth, Laurie Musch, Peter Parker and Jim Torpey were the other top contenders for this award. All ten contenders were presented with a medallion in recognition of their achievement.

Col Bertwistle had an outstanding season officiating in First Grade achieving an extremely high average.

Dave McGrath officiated in Second Grade for the entire season and was also allocated to two Metway Cup games and one Coca-Cola game during the season.

Kev Beasley has been a member for 5 years and has cemented his place in Third Grade as a very competent umpire.

Terry Whiter only in his second season has shown a lot of promise officiating in 8 Sixth Grade games in his first season and then began this season in Fifth Grade but quickly progressed to officiate the last 8 games in Fourth Grade.

STATE ADVISOR'S REPORT

The National A.C.B. Umpires' Handbook became a reality during the season and has been widely acclaimed throughout Australia and indeed the cricketing nations of the World. After receiving a copy of the Handbook, England ordered a considerable number as did other nations. That book should be used as a reference book and read from time to time.

The elementary exam from the A.C.B. has been completed in draft form and the final copies should be available during the 1995/96 season. This National exam will give umpires an A.C.B. ticket - not just a Local or State Association ticket. An exam for Grade Umpires will follow the elementary exam which is set mainly for non-grade umpires eg. School and underage competitions, player/umpire etc.

In Queensland, the advisor continues to have the invaluable support of the Q.C.C.A. and Queensland Cricket. All areas of the A.C.B. "white paper" in connection with the lines of communication and coaching are now in place and working very well. This is in no small way attributed to the Country Representative Member - Wayne Petersen.

EXAMINATION AND COACHING REPORT

The advent of an expanded panel has been productive in that it reduced the workload to each member of the panel.

Examination - A total of 127 umpires passed the exam during the past year. These umpires represented 17 different Associations throughout Queensland and excludes our own new members. Appreciation to Parry Scott (Metropolitan Zone Delegate) for his work in supervising exams for 2nd Division, Church, Warehouse and Women's Cricket.

Coaching - Only two major seminars were held during the past season. They were for the Redlands District and Ipswich Cricket Umpires Associations. Many Associations which previously called on our expertise are now conducting their own seminars. The major Country seminars were hosted by Beenleigh, Laidley/Toowoomba, Gympie, Gladstone and Prosperpine. Congratulations to all concerned for your effort and organisation at their venues.

Our own seminar at Maroochydore was well attended and generally agreed as the best one yet. Remember the main aim of our seminars is to get to know your fellow umpire better. GRADE ALLOCATION PANEL REPORT

Firstly, a big thank you to the members of the Panel. Whilst, it is great to have so many umpires, the pleasant downside is one giant headache for the allocation panel who to pick, who to leave out, who to promote and who to demote. All are problems not treated lightly by the Panel and several agonizing hours are spent every second Tuesday night. Remember, those cards back to the Q.C.A. by Monday helps enormously by the Panel not having to guess whether you are available or not.

One disturbing trend during the past season was the unusually high number of members not available for either one day or the whole match. In fact, only 10 members officiated in the 12 fixture games this season. Members should therefore by very conscious of the fact that progression goes hand in hand with dedication.

During the 1994/95 season, 80 members (an increase of 4) officiated in one or more Queensland Cricket grade games. Unfortunately, our objective to provide 60 umpires for both Saturdays was only achieved for 6 of the 12 rounds, but at least on these occasions, surplus umpires were allocated to Second Division. The number of umpires who were available for each round were:

The average number of umpires who officiated per round was 59.3, a slight improvement on the previous season. What is significant is that over the last five years, the average number of umpires per round has increased from 48 in 1990/91 to nearly a full complement in 1994/95. The Association should be proud of this achievement.

The Allocation Panel also allocated umpires on Sundays to the Metway Super League games, the Coca Cola One Day Competition, the Under 19 Competition and the Lord Taverner's Under 16 Competition. With only two exceptions, all games had a full complement of umpires.

With the amount of cricket, the increasing number of teams and the distance of travelling involved in the Sunday competitions, umpires are to be thanked for their commitment and dedication to these competitions.

The Allocation Panel considers the 1994/95 season to have been one of consolidation and we look forward to next year's challenge of having to find 64 umpires each Saturday to have 2 umpires per game.

(These policies do not require the application of all Statements of Accounting Concepts and Accounting Standards).

Qualification

As is common for organisations of this type, it is not practicable for the Association to maintain an effective system of internal control over donations, subscriptions and other fund raising activities until their initial entry into the accounting records. Note 1: Accounting policies:

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Queensland Cricket Umpires Association's constitution to prepare accounts. The Executive Committee has determined that the Association is not a reporting entity as defined in Statement of Accounting Concepts 1 "Definition of Reporting Entity". Accordingly there is no requirement to apply accounting standards in the preparation and presentation of the report.

Consistent with prior years the Executive Committee has used the cash basis of accounting with additional recognition for the depreciation of the Association's fixed assets. The cash basis of accounting means that income is recognized when cash is actually received, not when it is due to be received, and expenses are recognized when the payments are made rather than when a liability exists.

Consistent with prior years the value of inventory on hand has been determined on the basis of normal sale price.

OTHER UMPIRES' ASSOCIATIONS

The 1994/95 season saw a number of representative games played in the country at Bundaberg, Maryborough, Mackay, Toowoomba, Beenleigh and Caloundra. The Association was pleased to have representatives from Redlands, Warehouse, Second Division and Gold Coast attend some of our monthly General Meetings.

Zone delegates have submitted reports about umpiring activities in their zone for the 1994/95 season. These reports are outlined below.
